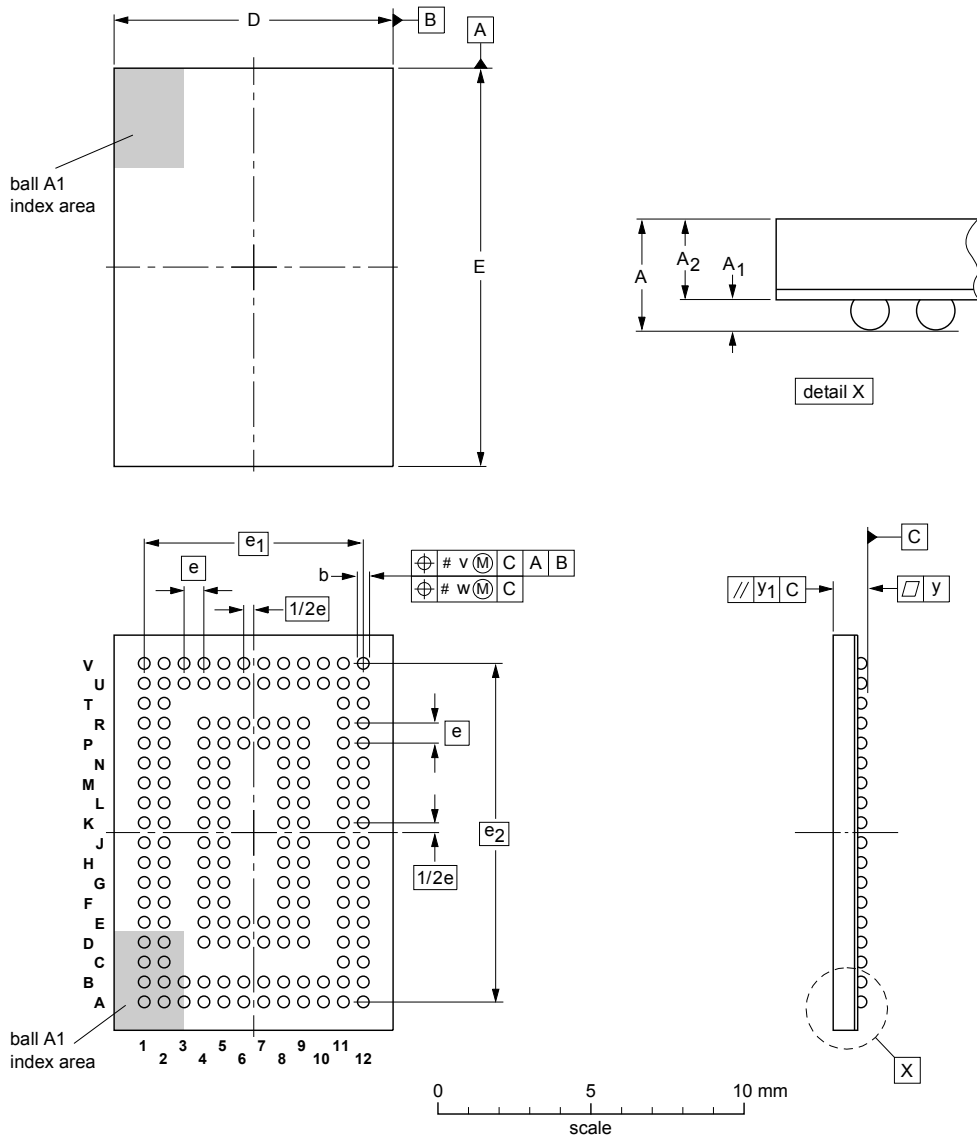

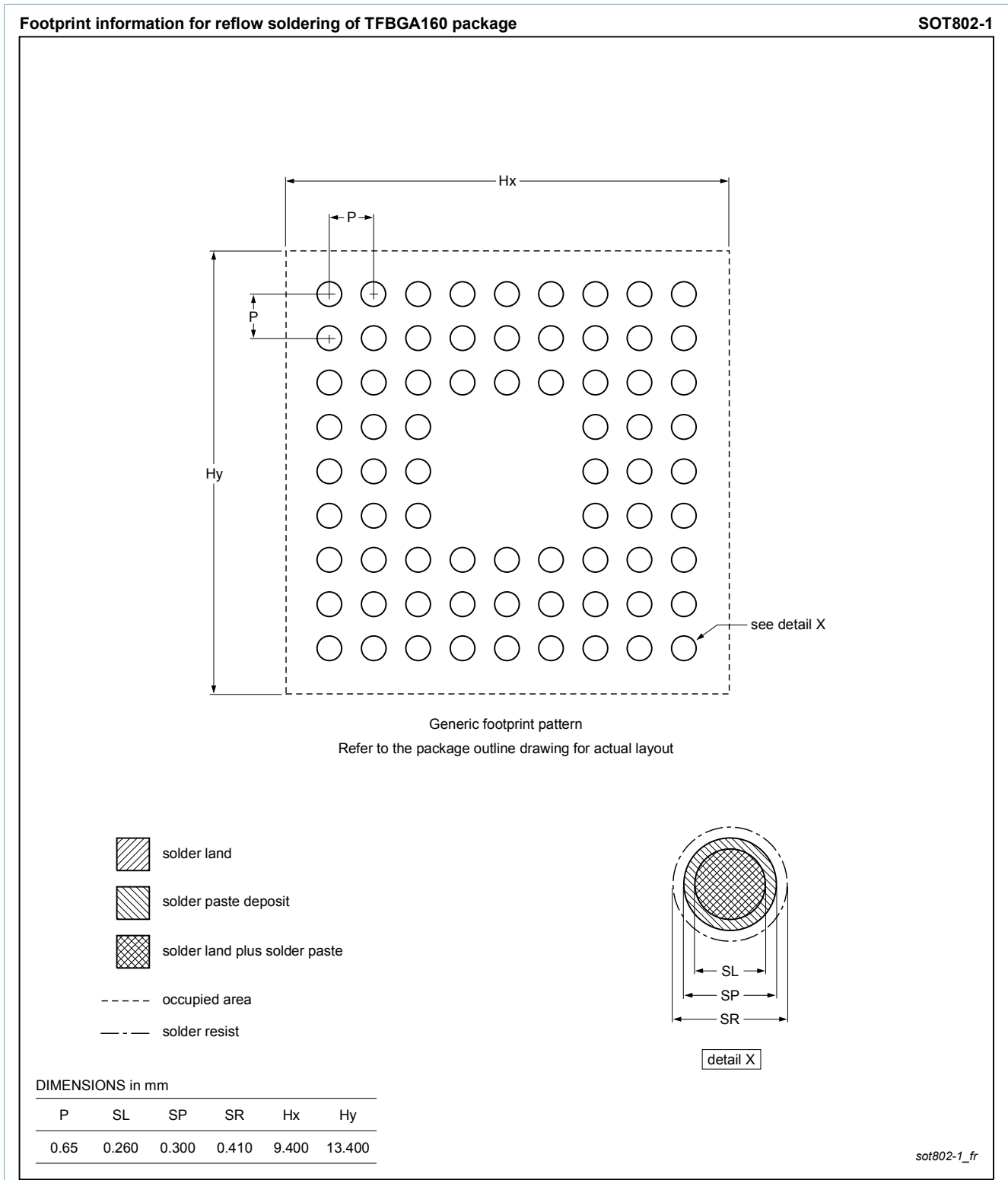


Fig. 2. Reflow soldering footprint for TFBGA160 (SOT802-1)
